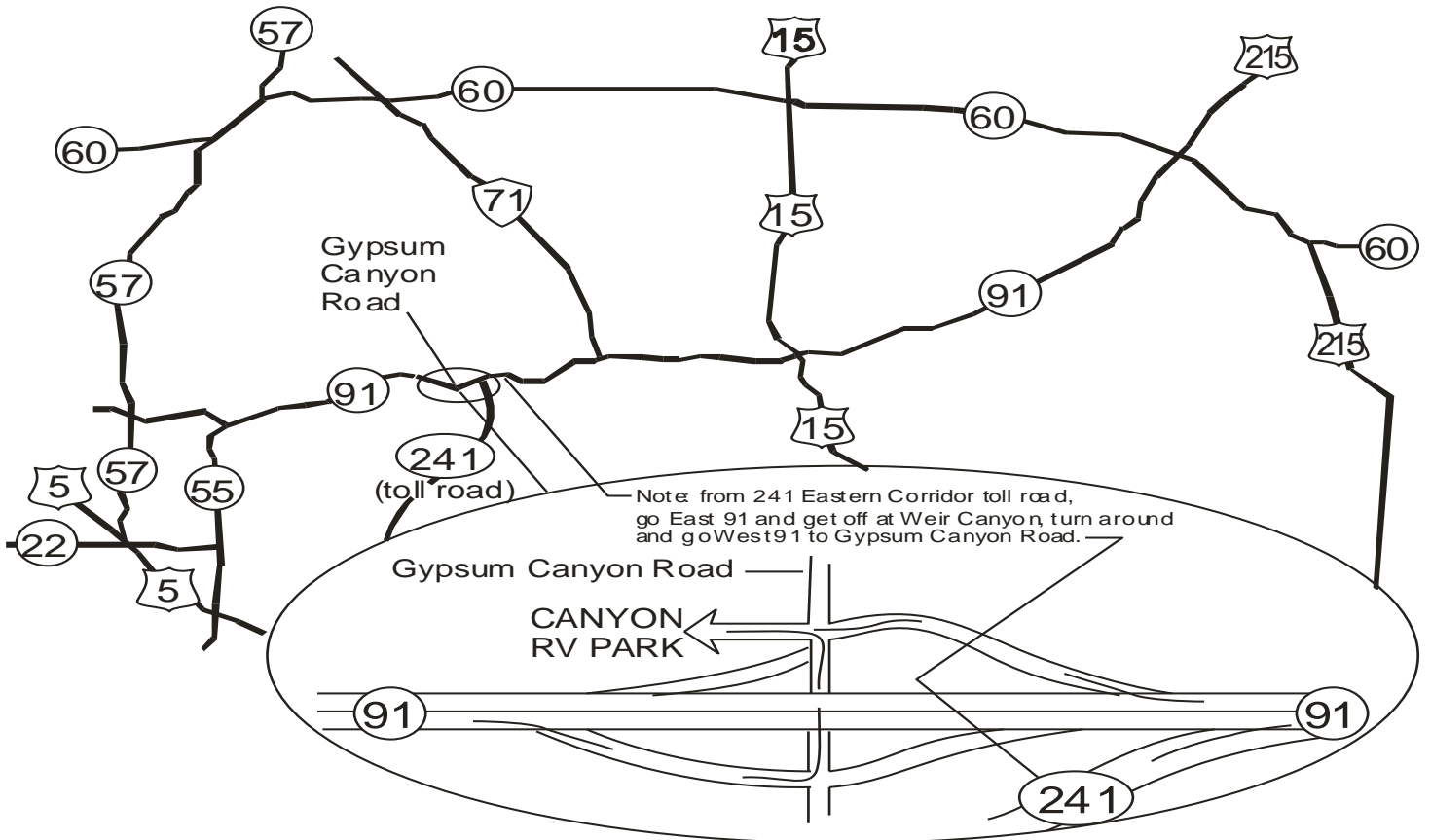

Park is in the Northwest corner of the 91 & Gypsum

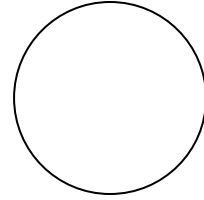
Turn right after passing through the entry gate.

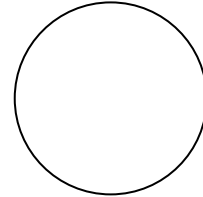
