DIRECTIONS TO FIELD TRIAL GROUNDS

FROM State Route 71: Take the Euclid Ave./Butterfield Ranch Rd. exit. Go NORTH 2 miles on Euclid Ave. (past the main entrance to Prado Regional Park) to Pine Avenue; turn right (EAST). Go 1.2 miles to Chino Corona Road and turn right (SOUTH). Drive past California Institute for Women (on your right side) to the Stop sign at the intersection of Chino Corona Road and Cucamonga Ave. Go straight on Cucamonga Ave. Go 1 mile to McCarty Road (not marked) and turn left. Go about ¼ mile and turn left into Model Airplane Park. **Please park as far away from runway as possible.**

FROM 91 freeway traveling EAST or WEST: Take SR 71 Corona Expressway North. See "From State Route 71" above.

FROM Interstate 15 traveling North: Take 6^{nd} Street Exit West in Norco to Hamner Ave. Turn Right on Hamner Ave. Go to Schleisman. Turn left on Schleisman(continue at Φ below).

FROM Interstate 15 traveling SOUTH: Take Limonite Ave. Exit West. Go to Archibald. Turn Left on Archibald. Go to Scheilsman and turn right. (continue at Φ below)

① Go straight (Schleisman becomes Pine Ave.) to Chino Corona Rd. and turn left. Drive past California Institute for Women (on your right side) to the Stop sign at the intersection of Chino Corona Road and Cucamonga Ave. Go straight on Cucamonga Ave. Go 1 mile to McCarty Road (not marked) and turn left. Go about ¼ mile and turn left into Model Airplane Park. Please park as far away from runway as possible.

RUNNING ORDER OF THE TRIAL

The drawing of entries for all classes will take place at 7:00 AM (PST) on the field trial grounds. All dogs must be present on the field trial grounds at the time of the drawing to be officially entered. Open Dog & Open Bitch classes will be run consecutively but not necessarily in that order. All entered dogs must be 6 months of age or older on the day of the event. Bitches in season are eligible to run in the Open Bitch class. Field Champions will run after the completion of the open classes. The winners of the Open classes (if eligible) will compete with the winner of the FC class (if eligible) for Absolute.

Absolute will be run in braces or as a trio at these trials, to be determined by the Field Trial Committees. The field trials will be held regardless of weather. DCSAV and Sierra reserve the right to run classes in Divisions if necessary for the timely completion of the trial.

PRIZES

The Dachshund Club of Santa Ana Valley (DCSAV) and the Sierra Dachshund Breeder's Club of Los Angeles County (SDBC) offers Rosettes for all placed dogs and NBQ in the following classes: Open Dog and Open Bitch, or Open Combined, and Field Champion. The clubs also offer a Rosette for the Best Open and Absolute winners. DCSAV offers (Saturday) a Neoprene Dachshund Wine Tote Bag for 1st place in all classes, a Light-up LED Bunny for Best Open and a Metal Bunny Tealight Holder for Absolute. Sierra offers (Sunday) a Bunny Bowl for all 1st place class winners, a Toy for 2nd through NBQ winners, a Bunny Mug for Best Open and a Porcelain White Rabbit for Absolute.

ADDITIONAL INFORMATION

DCSAV and SDBC will allow hounds to wear tracking collars at these field trials. The collar surface against the dog's neck shall be flat (no protrusions). While the hounds are under judgment, hand held devices must be turned off. Hand held devices may be turned on only after the hound has been eliminated from competition by the judges or judgment has ceased. Note that Procedure 3D of the AKC "Field Trial Rules and Standard Procedure for Dachshunds" is still in effect (page 19-20).

Note: There are no potluck lunches at these trials!

Continental breakfast is free. A hot lunch will be served daily at the field trial site for \$5.00. Judges' lunches are complimentary on the day(s) they judge. Field Marshals' lunches are also complimentary on the day(s) they marshal. Payment for each day's lunch must be made before roll call to ensure we have enough to serve everyone.
