Basset Hounds, Beagles, Dachshunds, Harriers, Petit Basset Griffon Vendeens and Grand Basset Griffon Vendeens registered with the American Kennel Club (AKC).

Basset Fauve de Bretagne which are listed as AKC Foundation Stock Service Breed.

Including all these listed scent hounds with ILP or PAL numbers.

Spayed and neutered listed scent hounds may enter.

Hounds will be judged by the Rules used by the Basset Hound Club of America.

STAKES are LIMITED to a total of 20 entries each day Stakes will be run concurrently in two separate areas.

* STAKES are LIMITED to 2 (two) Stakes per Owner/Household * any additional stakes will be entered as Alternates, so please identify which stakes are your primary stakes if you have more than two.

If you have not entered and plan on entering the day of the trial, please contact the HPT Chair and Secretary the night before, please do not wait until the last minute.

Entries Close each day 2/17 & 2/18 at 6:30 am
Or when all 20 stake entries are filled.

IMPORTANT UPDATES:

Changes in entries or stakes will close on Friday, February 16th at 6:00 pm PST, for Saturday, February 17th, the HPT Chair and Secretary will need to be notified of any changes, after that time no changes to your HPT entries will be allowed. You will need to fill out a new entry form with your updated changes and the **completed** entry form will need to be given to the HPT Chair or Secretary by 6:30 am PST on Saturday, February 17th with any applicable fees for these final changes to be accepted.

Changes in entries or stakes will close on Saturday, February 17th at 6:00 pm PST, for Sunday, February 18th, the HPT Chair and Secretary will need to be notified of any changes, after that time no changes to your HPT entries will be allowed. You will need to fill out a new entry form with your updated changes and the **completed** entry form will need to be given to the HPT Chair or Secretary by 6:30 am PST on Sunday, February 18th with any applicable fees for these final changes to be accepted.

All entries submitted must be <u>legible</u> and clearly state the stake they are entering, and whether they are running as Qualifying or Non-Qualifying. For each stake entered (whether running Qualifying or Non-Qualifying) a <u>complete</u> legible entry form must be filled out and submitted with appropriate fees. For Brace stakes and Pack stakes all dogs must be named at time of entry and the completed entry forms submitted. Completed entry forms must received for all the members of a Brace or Pack stake by Friday, February 16th at 6:00 pm PST, for Saturday, February 17th; and Saturday, February 17th at 6:00 pm PST, for Sunday, February 18th with appropriate entry fees. No email or faxed entries will be accepted.

If entry forms received are illegible, they will be returned and must be resubmitted after the corrections are made. We have provided fillable entry forms for easy, clear, readable entries.

All <u>new</u> entries must be completed and turned in by 6:30 am PST, the day of the HPT, <u>if there are available stakes or alternate stakes open</u>. After that time no new entries will be accepted.

Only bitches in season will be allowed to withdraw with a full refund if the HPT Secretary is notified by Wednesday, February 14th.

No changes to the running order and judges will be made after roll-call, only in emergencies will changes be allowed if approved by the HPT Chair and Secretary.

Exhibitors and Judges – <u>Please</u> be sure to sign your score sheets before you leave the HPT grounds or they will not be submitted for recording to the BHCA HPT Databank and the AKC. Just as in any AKC Event the Exhibitor/Participants are responsible for the accurate recording of their dogs score, whether they are responsible for the error or not, so please be sure to check your scoresheets before you sign them and leave the HPT grounds.

In a BHCA sanctioned test, a Hunting Hound (HH), Senior Hunting Hound (SHH), Master Hunting Hound (MHH), or Master Hunting Hound Excellent (MHE) may be earned. Each entry must specify "Q" or "NQ" indicating whether or not that hound is intending to qualify for a title. Only one "Q" entry may be submitted for each hound at a test. A hound must earn 3 qualifying scores in solo, brace, or 2- coupled pack to earn an HH. Once having the HH, the hound must compete in one of the other remaining stakes for it's SHH, and then in the remaining stake to earn an MHH and MHE.

Awards: Ribbons will be awarded to all qualifying hounds. For hounds completing 3 qualifying scores at each level a Rosette will be given and a title certificate with hound's name, owner's name, date will be mailed to all qualifying hounds.

Hounds will be judged using the following categories of hunting ability: (1) ability to find game, (2) use of voice, (3) line ability, (4) adaptability, (5) determination each on a scale of 1 to 10; (6) gun shyness is judged on a pass/fail basis. In order to pass this test a hound must score at least 5 on each of the 5 categories and an average of 6 for all categories when all judge's scores are tallied. Handlers shall be exhibit control of their hounds during testing.

Exhibitor Information: This test is open to hounds of the breeds specified that are registered with the American Kennel Club or have obtained ILP or PAL numbers, except for aggressive hounds or hounds suffering from any deformity, injury or illness, which may affect the hound's physical or mental performance.

Safety of the hounds is a primary concern. The test running grounds are open meadows and olive groves. No releasing dogs on rabbits except as instructed by the judges during the trial. All hounds must be on leash at all times except when being tested. It is expressly understood that the exhibitors alone are responsible for the behavior of their hounds, guests and children. Anyone engaging in unsafe or disruptive behavior may, at the discretion of the test committee, be asked to leave the trial site.

Bitches in season are not permitted at this test and entry fee will be refunded if a bitch entered in solo stake is in season at time of test. If a bitch in season has been entered in brace or pack another hound may be substituted. Refunds will be given if the secretary is notified by Wednesday, February 14, 2024.

Judges are not required to wait for hounds. Owners or handlers of each hound are solely responsible for the dog being ready to perform.

By signing your entry form you are agreeing to abide by these rules and regulations.


DIRECTIONS TO HUNT TEST GROUNDS -

PLEASE Check for current road closures, some roads maybe closed due to flooding

FROM Interstate 15 Freeway: Take Limonite Ave (exit 103) West until it dead ends at Archibald Ave. and turn left (South). Go 1 mile to Schleisman Rd and turn right (West). Schleisman Rd becomes Pine Ave. west of Hellman Ave. Continue West on Pine Avenue to Chino Corona Road and turn left (South). Drive past California Institute for Women (on your right side) to the Stop sign at the intersection of Chino Corona Road and Cucamonga Ave. Go straight on Cucamonga Ave.

FROM 91 Freeway: Take SR 71 Corona Expressway North. Take the Euclid Ave./Butterfield Ranch Rd. exit. Go NORTH 2 miles on Euclid Ave. (past the main entrance to Prado Regional Park) to Pine Avenue; turn right (EAST). Go 1.2 miles to Chino Corona Road and turn right (SOUTH). Drive past California Institute for Women (on your right side) to the Stop sign at the intersection of Chino Corona Road and Cucamonga Ave. Go straight on Cucamonga Ave.

The model airplane facilities have NO SHADE so bring your own. Do not leave dogs in vehicles unattended unless you are absolutely certain of their safety
